Election of New Officers,

 - 1. Roofing Special Assessment minimum, and separate payments to the reserve
 - 2. Several Trees are dying and need to be replaced
 - 3. Potholes in driveways and private lanes caused by heavy loaded garbage trucks, need to be refilled prior to snow plow season
 - 4. Access to mail boxes during heavy snows
 - 5. Replacing the dead boxwood bushes

All questions were answered by the Board to the best of their knowledge, and other answers needed will be deferred until a good followup answer will be made.
